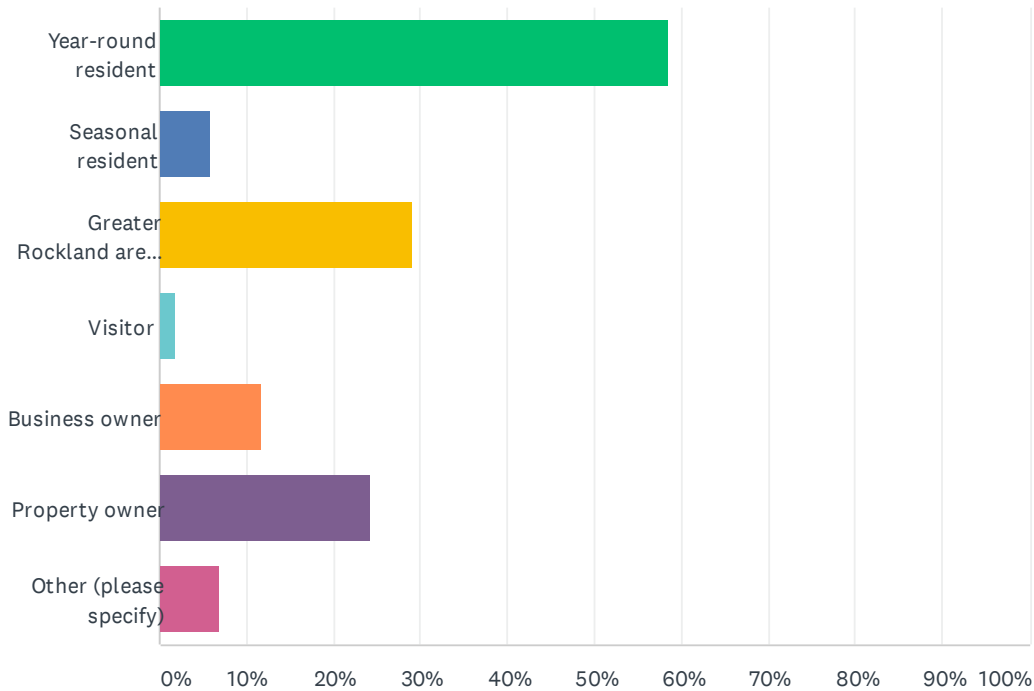


Q1 What is your relationship to Rockland? (Select all that apply)

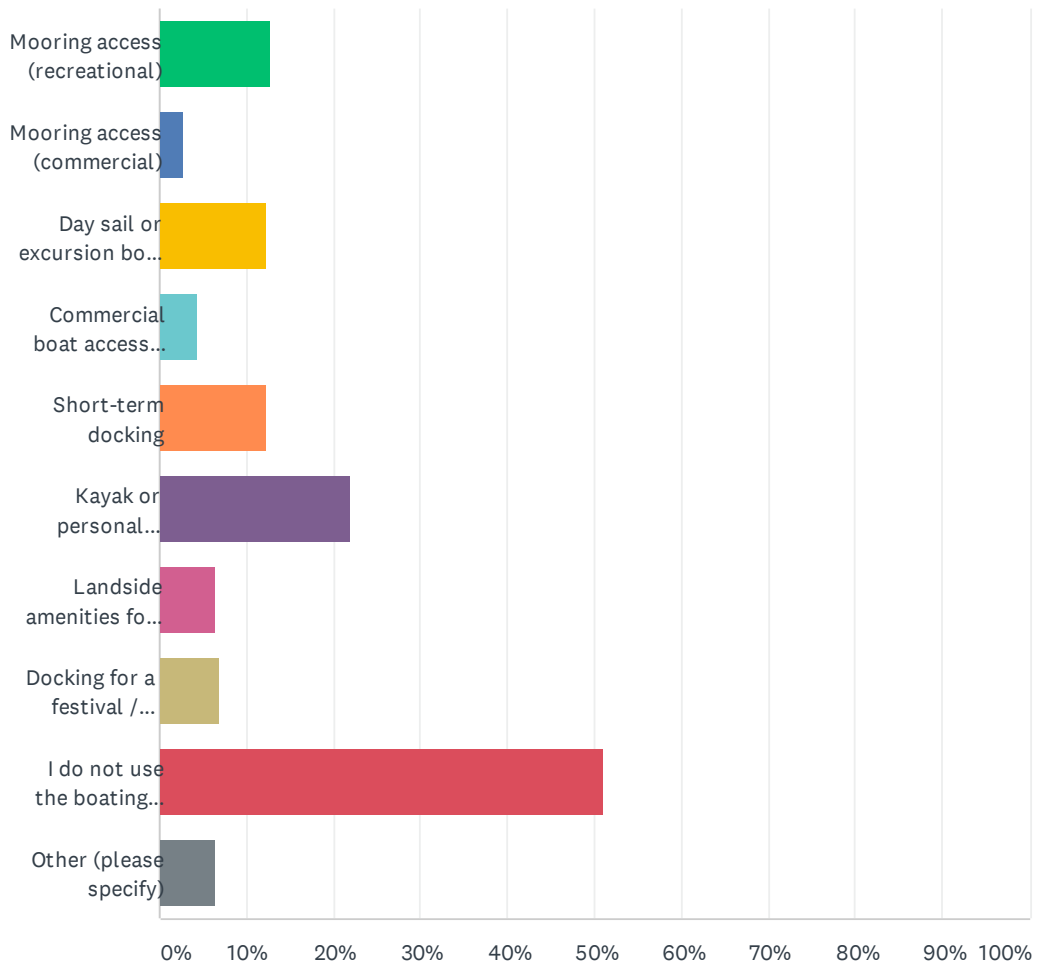

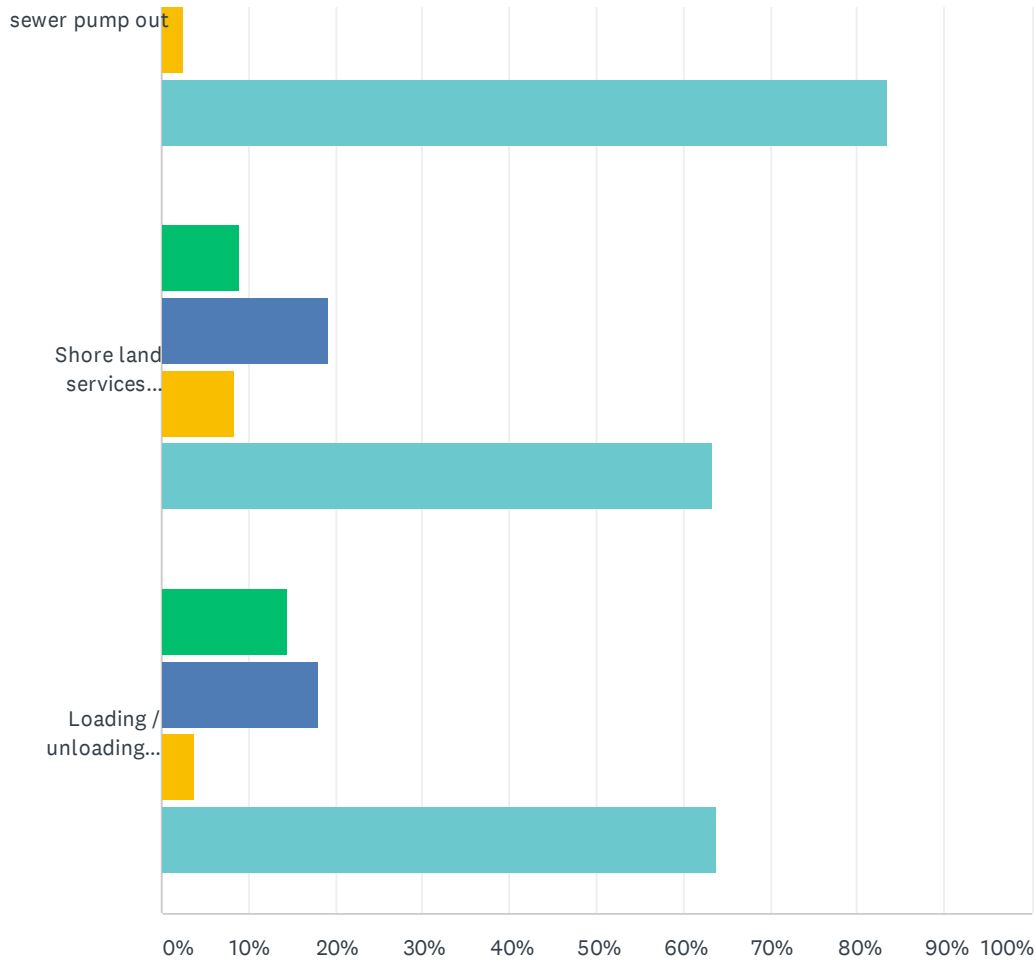

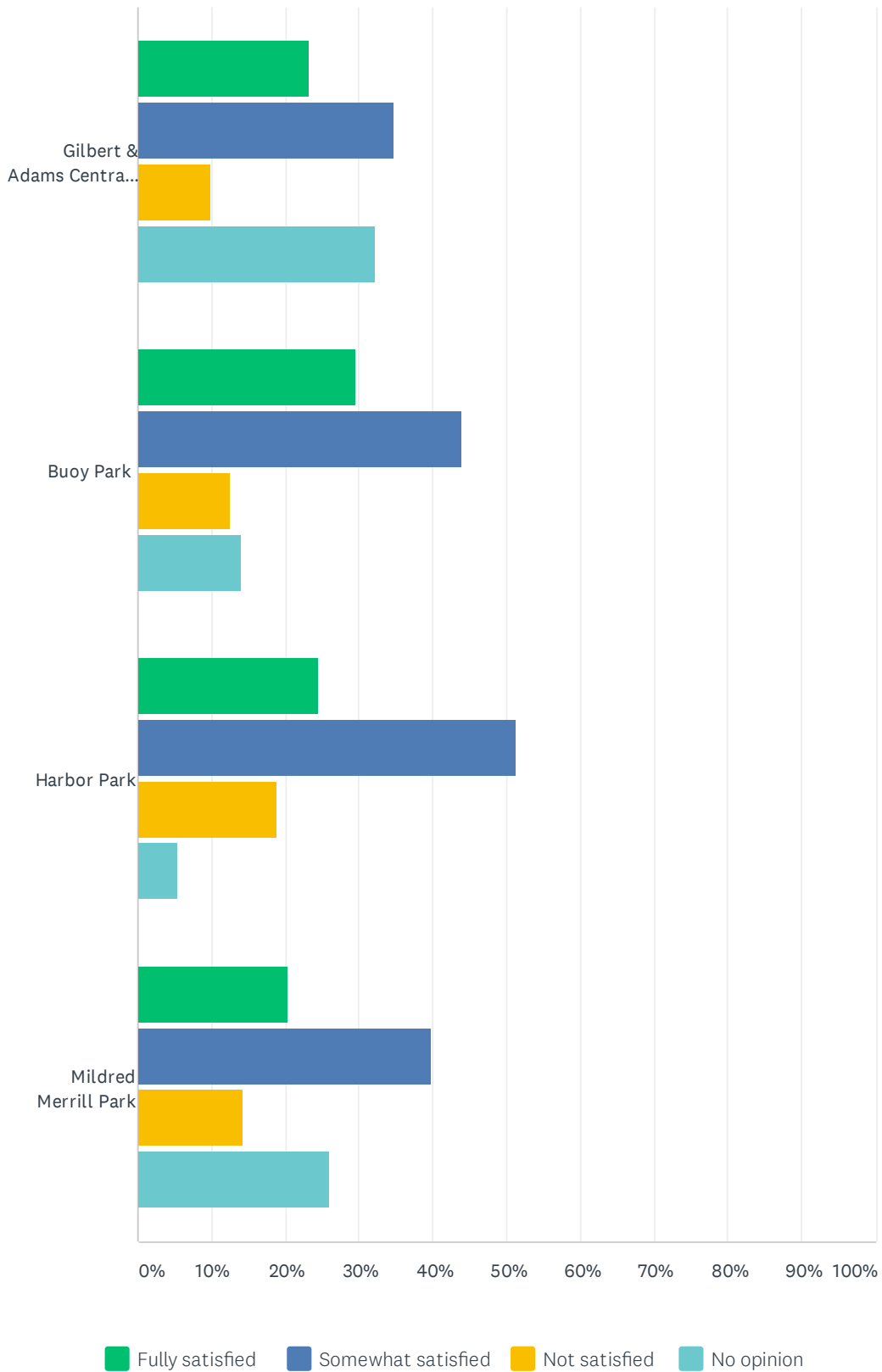

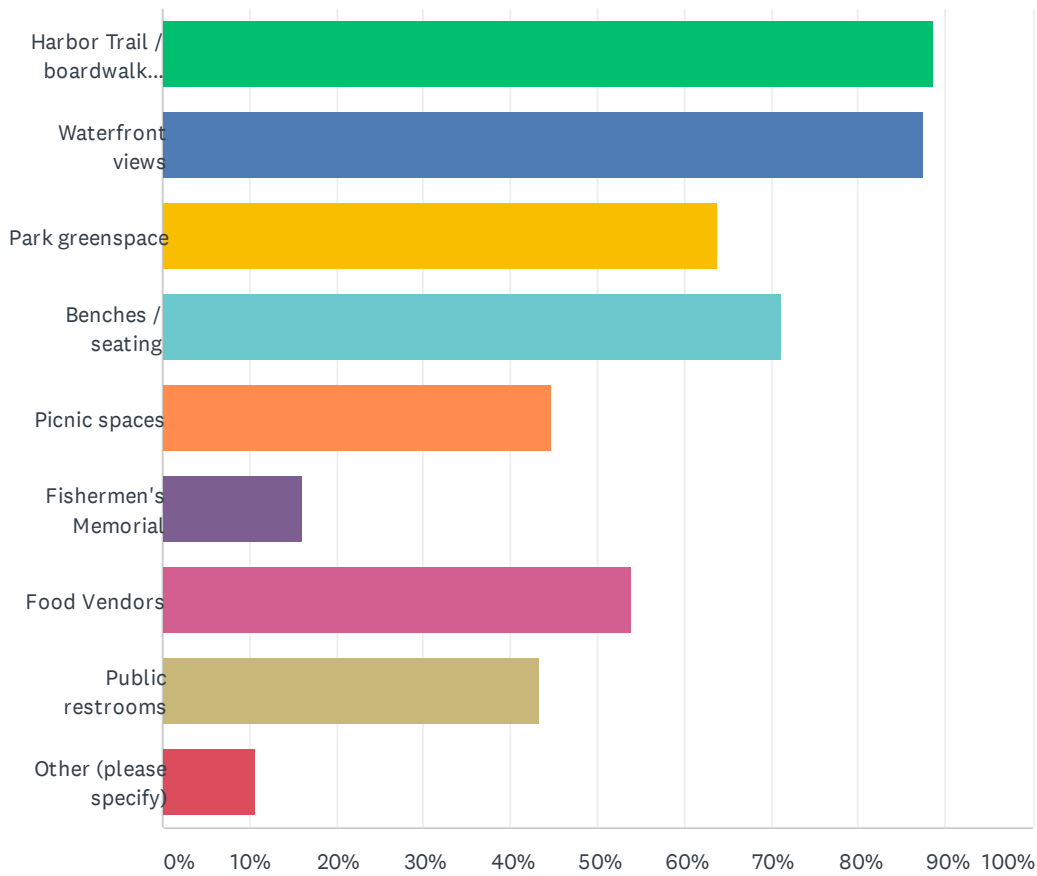

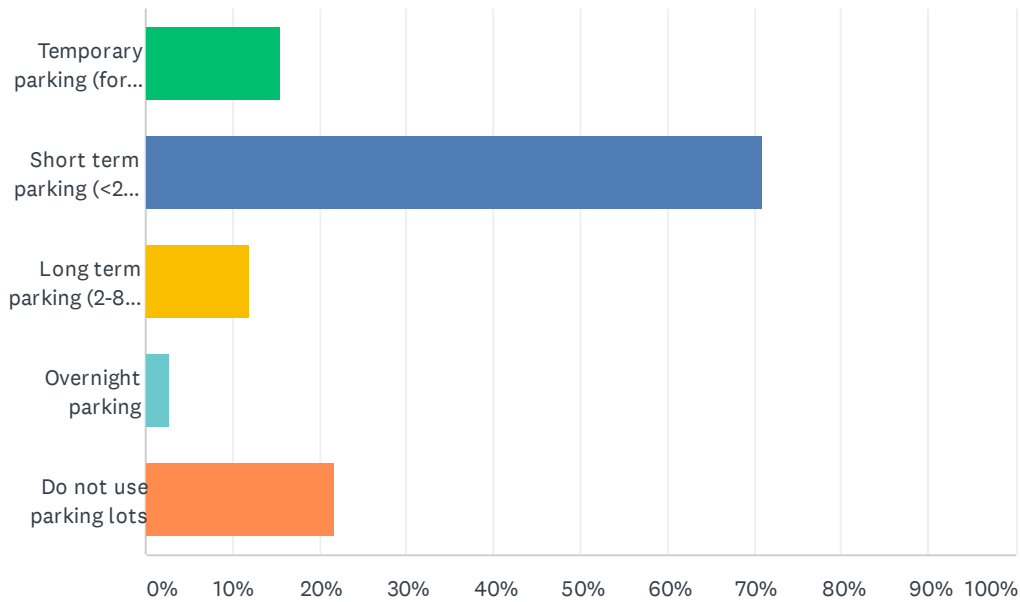

Q11 Which of the following reflects your use of the parking lots at Harbor Park and Buoy Park? (Select all that apply)

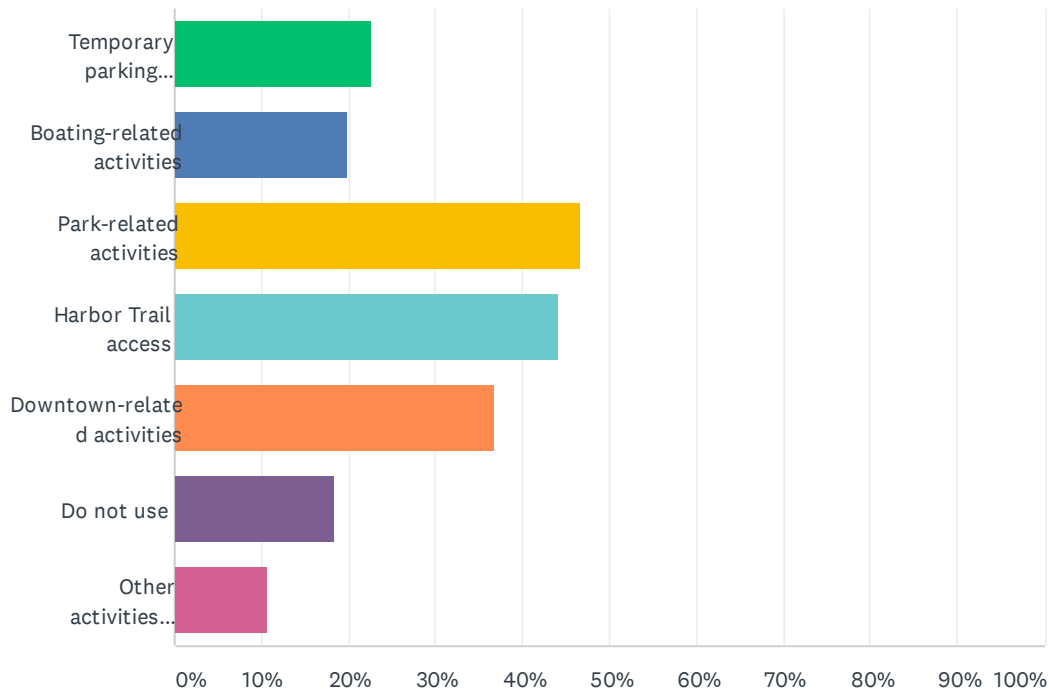

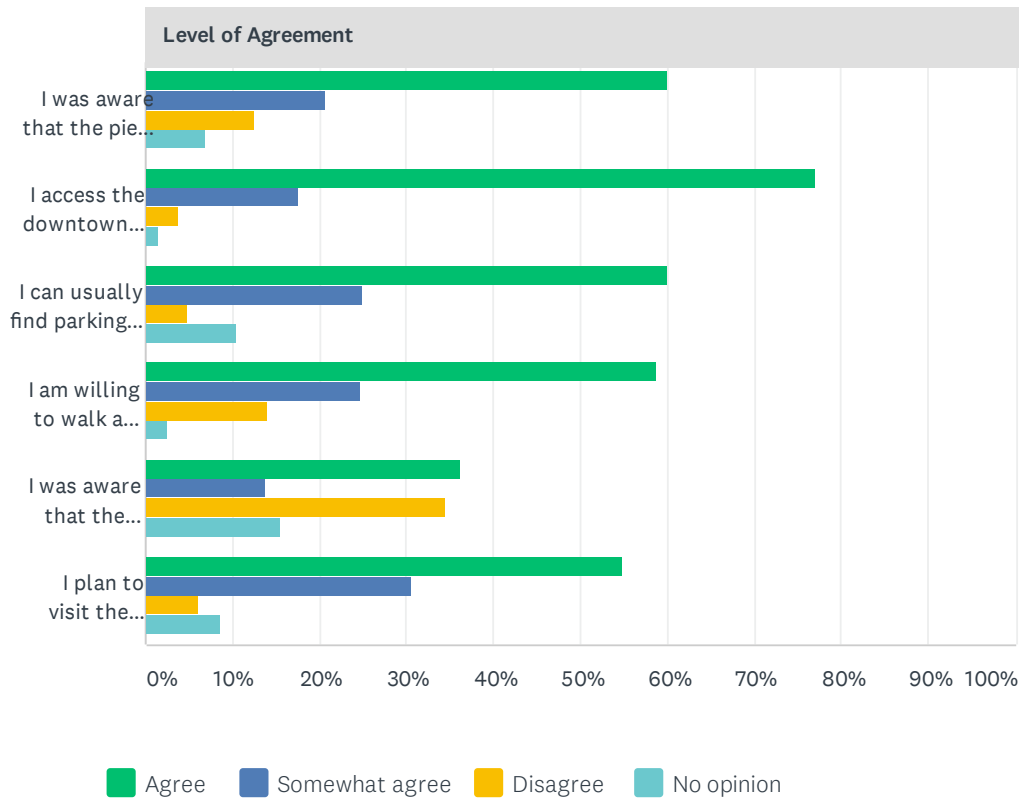
